## Do you qualify?

Earned income and adjusted gross income (AGI) must each be less than:

- **\$50,162** (\$55,952 if Married Filing Jointly) with three or more qualifying children
- **\$46,703** (\$52,493 if Married Filing Jointly) with two qualifying children
- **\$41,094** (\$46,884 if Married Filing Jointly) with one qualifying child
- **\$15,570** (\$21,370 if Married Filing Jointly) with no qualifying child

### The maximum EITC for 2019:

- **\$6,557** with three or more qualifying children
- **\$5,828** with two qualifying children
- **\$3,526** with one qualifying child
- **\$529** with no qualifying child

## IMPORTANT!

### Be prepared to bring:

- Photo ID and Social Security cards for all dependents to be listed on your tax return
- A copy of last year's tax return
- W-2 forms for each job, 1099-R, 1099-INT/DIV, 1099-G, 1099 SSA, 1099MISC, Marketplace 1095-A, 8962 for Premium Tax Credit, 8965 Exemption, and Employer 1095-B
- If claiming childcare expenses, documentation, & provider's Tax ID
- Form 1098T and 1098-E (tuition and fees paid)
- If married and filing jointly, spouse must be present on the virtual call
- If you prefer direct deposit, bring a voided check to verify the account routing and account number
