#### **Statement Of Need**

Westchester County Department of Social Services, on behalf of the Westchester-Putnam Workforce Development Board (WPWDB), is soliciting price quotations for a consultant to act as One-Stop Operator who has the capacity and expertise to carry out the functions One-Stop Operator as described in this RFQ and as required under the Workforce Innovation & Opportunity Act (WIOA) and it Regulations. The consultant is expected to have knowledge of the WIOA legislation, regulations, as well as the local and regional strategic plans<sup>1</sup>.

The counties of Westchester and Putnam, with the exception of Yonkers, have been designated as joint counties Local Workforce Development Area (the "WPWDB") by the Governor of the State of New York. The County Executives have appointed the members of the local Workforce Development Board (WDB). The WDB has selected the departments of social services from each county to provide the career services career services as requested by the WIOA, sec.134(c)(2) for their respective county. Please note that the One-Stop Operator, which this RFQ is soliciting, will not be required to provide any career services.

# Background

Westchester-Putnam One-Stop Career Center System operates through a network of four Career Centers located the local area; and several libraries and partner locations. The system also includes the use of our websites at <a href="www.westchesterputnamonestop.com">www.westchesterputnamonestop.com</a> and the NYSDOL online case management system, One Stop Operating System (OSOS). These centers provide a variety of workforce preparation, career and training services and resources under one roof that jobseekers may access to help them engage in preparation for and to launch their job search efforts. The Career Centers also assist local employers to meet their workforce needs for qualified personnel. Businesses use the career center and website to post jobs, search for candidates, and apply for funding to support training new and existing workers.

As mentioned before, the Career Services are provided by the Westchester and Putnam County Departments of Social Services in their respective counties. The One-Stop Operator, solicited under this RFQ will not provide and career services in any of the centers or affiliate sites.

#### **Job Seeker Services**

The career services providers' role includes outreach and recruitment for program applicants, determine eligibility for programs, assess the interest and skill levels of job seekers, link and fund job training activities for job seekers, and assist with job placement and follow up with employees. All of these activities are provided along with the full range of supportive services necessary for individuals to ensure that they have success in the job search and employment process.

Program services for eligible adults, dislocated workers and youth are provided in an integrated

service delivery environment which means co-enrollment of the job seeker into relevant and eligible programs along with a seamless approach to services offered.

#### **Business Services**

Businesses receive services from the business services staff and may use the One Stop website to post jobs, screen resumes and to apply for funding to train their new and incumbent workers under the Hire Westchester-Putnam Initiative. The WDB also has contract with local a vendor that includes a Business/Industry Sector Manager and a Youth Work Experience Manager who complements the career centers' business engagement efforts.

#### **Youth Services**

The WDB has procured and contracts with six (6) local entities to provide WIOA youth services under its Workforce Development Academy for Youth (WDAY).

**Term of Services:** The contract will be effective July 1, 2017 to June 30, 2021.

# **Scope of Work for One-Stop Operator**

For purposes of this RFQ, WDB defines One-Stop Operator services as monitoring and providing technical assistance to career centers and their affiliates.

The One-Stop Consultant selected will provide monitoring and technical guidance to the one stop career center partners, WDAY (WIOA) contractors, Youth Build contractors, LEAP contractor and other related program that fall under WIOA regulations.

The One-Stop Operator is expected to collaborate with the WDB to provide oversight of the management and coordination of services between the WIOA Core and Required partners. The One-Stop Operator will also monitor the coordination of the delivery of services of partners and providers by seeking partner involvement in and sharing of resources within the One-Stop system, integrating a multi-funding/multi-program delivery system.

The successful respondents must be able to provide the following services:

- Demonstrate up-to date information of WIOA regulations and guidelines, specifically dealing with core and mandated partners to provide services to those who possess barriers to employment, especially those with disabilities. Partners are recommended to read TEGL 16-17.
- Provide mandated monthly reports reflecting all partner activities within the One-Stop Centers.
- Ensure that partners provide the required access to their programs and activities through the One-Stop system which are consistent with the terms of the MOU and appropriate regulations.

- Implement operational policies that reflect an integrated system of performance, communication, and case management and uses technology to achieve integration and expanded services
- Ensure that One-Stop Center staff are trained/cross-trained (as appropriate) and equipped with the skills, knowledge, and tools needed to increase staff capacity, expertise, and efficiency in order to provide superior services to job seekers, including those with disabilities
- To provide and coordinate at least two bi-annual specialized trainings that may be beneficial to One-Stop Career Center staff, Partners and contractors.
- Ensure compliance electronic linkages of all one-stop partners designated by One-Stop partnership MOU and the local & regional plans to improve communication, referral, service delivery, and tracking of performance of the partners
- Create a collaborative work environment for the One-Stop Career partners, linking all the resources with the One-Stop system to maximize service delivery to job seekers
- Coordinate and facility partner meetings in the Center at least quarterly

# **Applicant Eligibility**

An entity (public, private, or nonprofit), or consortium of entities (including a consortium of entities that, at a minimum, includes 3 or more of the One-Stop partners described in WIOA Section 121, subsection (b)(1)), of demonstrated effectiveness, located in the local area, which may include:

- An institution of higher education;
- An employment service State agency established under the Wagner-Peyser Act on behalf of the local office of the agency;
- A community-based organization, nonprofit organization, or intermediary;
- A private-for-profit entity
- A government agency; and
- Another interested organization or entity, which may include a local chamber of commerce or other business organization, or a labor organization.

**EXCEPTION:** Elementary schools and secondary schools shall <u>not</u> be eligible for designation or certification as one-stop operators, except that nontraditional public secondary schools and area career and technical education schools may be eligible for such designation or certification

# **Request for Clarification**

#### **Evaluation Criteria**

All proposals will be reviewed to determine if they have met the requirements of this RFQ. Those that meet the requirements will be deemed "responsive", and will be evaluated by the review committee and ranked. Those proposals that do not meet the requirements of the RFQ will be deemed "non-responsive" and will be rejected.

The WPWDB reserves the right to consider a proposal as "non-responsive" should it believe that the applicant will be unable to perform the services requested at the level required or within the program's budgetary and/or time restrictions.

WPWDB also reserves the right to negotiate with applicants to this RFQ, if necessary, to refine or expand the statement of work, fee arrangements, or any other aspect of the services to be provided.

Evaluation of your proposal /quotation will be based on the following criteria:

- 1. Experience and knowledge
- 2. Capacity to provide service
- 3. Qualifications
- 4. Cost
- 5. Proposal Completeness

#### **Required Elements of Proposal/Proposal Format**

Respondents are required to submit a hard copy. Respondents must submit a five-page written, 12pt font single space proposal and one (1) electronic version of **all** submission documents on a USB portable dive or CD in Microsoft Word format. The five page limit excludes the Cover Letter.

# A. Cover Letter (Schedule "A")

Respondents should submit a cover letter expressing their interest in the project. The letter should contain, at a minimum, the following information:

- 1. A statement of your company's interest in providing s One-Stop Operator Services
- 2. Certification that the information and data submitted is true and complete to the best knowledge of the individual signing the letter.
- 3. Respondent's name, address, telephone number, fax number and e-mail address of the individual to contact regarding the submittal.
- 4. An authorized principal or partner of a firm shall sign the letter.

# **B.** Qualifications and Experience of the Respondent(s)

The Respondents should show evidence of substantial knowledge and experience in working in a workforce development, human services, education, economic development, or other similar fields in order to successfully perform the duties required in the scope of services described in Scope of Work.

# C. Qualifications and Experience of Key Staff

Respondents shall identify the key individual(s) who will be working on this project (by name and position) and describe the work tasks completed. The respondent must also provide experience qualification of the individual(s), describing previous experience on similar projects in similar roles, educational background. Resume(s) of these key individuals may also be included and will be counted towards the page limit. Respondents shall also list any professional affiliations, licensures, and certifications that are pertinent to the work described in the Scope of Work.

# D. Work plan and Deliverables

- **E. References** (Schedule "B")- Respondents shall submit names, addresses, e-mail and phone numbers of three (3) references familiar with the respondent's ability, experience, and reliability in the performance and management of projects of a similar nature.
- **F.** Cost Information The fee proposed for these services shall be indicated as part of the proposal. Failure to include the fee proposal amount with the proposal shall disqualify the proposal. If the fee is a not-to-exceed amount based on your estimate of hourly rates and costs necessary to complete the scope of work, you must provide a detailed budget outlining all such hourly rates and cost estimates.

Provide a separate Budget for the One Stop Operator activities being proposed. Contractors will receive reimbursement for actual allowable costs of operating the program. The Contractor will bill only for actual and accrued costs to meet immediate cash needs. All costs associated with contract payments will be supported by original documentation charged to appropriate cost classifications and subject to audit.

Each proposer must submit a proposed budget for each year and budget narrative for each budget line item, explain how the cost was calculated.

**G.** <u>Plan of Service</u> - The respondent must have a detailed plan for successfully completing the duties of a One-Stop Operator, as outlined in this RFQ. It is of key importance that the respondent's plan strongly adheres to the scope of work.

Electronic submissions are not allowed and late proposals will not be considered.

# **Legal representations Understandings**

Please take notice, by submission of a proposal in response to this request for proposals, proposing entity agrees to and understands:

- That any proposal, attachments, additional information, etc. submitted pursuant to this Request for Quotes constitute merely a suggestion to negotiate with the County of Westchester and is not a bid under Section 103 of the New York State General Municipal Law;
- Submission of a proposal, attachments, and additional information shall not entitle the
  proposing entity to enter into a service agreement with the County of Westchester for
  the required services;
- By submitting a proposal, the proposing entity agrees and understands that the County of Westchester is not obligated to respond to the proposal, nor is it legally bound in any manner whatsoever by submission of same;
- That any and all counter-proposals, negotiations or any communications received by a proposing entity, its officers, employees or agents from the County, its elected officials, officers, employees or agents, shall not be binding against the County of

Westchester, its elected officials, officers, employees or agents unless and until a formal written agreement for the services sought by this RFQ is duly executed by both parties and approved by the Westchester County Board of Acquisition & Contract, and the

Office of the Westchester County Attorney.

In addition to the foregoing, by submitting a proposal, the proposing entity also understands and agrees that the County of Westchester reserves the right, and may at its sole discretion exercise, the following rights and options with respect to this Request for Proposals:

- To reject any or all proposals;
- To issue additional solicitations for proposals;
- To issue amendments to this RFQ;
- To waive any irregularities in proposals received after notification to Proposers affected;
- To select any proposal as the basis for negotiations of a contract, and to negotiate with one or more of the Proposers for amendments or other modifications to their proposals;
- To conduct investigations with respect to the qualifications of each Proposer;
- To exercise its discretion and apply its judgment with respect to any aspect of this RFQ, the evaluation of proposals, and the negotiations and award of any contract;
- To enter into an agreement for only portions (or not to enter into an agreement for any) of the services contemplated by the proposals with one or more of the Proposers;
- To select the proposal that best satisfies the interests of the County and not necessarily on the basis of price or any other single factor;
- While this is a Request For Quotes and not a bid, the County reserves the right to apply the case law under General Municipal Law § 103 regarding bidder responsibility in determining whether a Proposer is a responsible vendor for the purpose of this RFQ process;
- The County assumes no responsibility or liability of any kind for costs incurred in the preparation or submission of any proposal;
- The County is not responsible for any internal or external delivery delays which may cause any proposal to arrive beyond the stated deadline. To be considered, proposals MUST arrive at the place specified herein and be time stamped prior to the deadline.
- Evaluation criteria are not necessarily listed in order of importance. The County reserves the right to weigh its evaluation criteria in any manner it deems appropriate.

# PROPOSAL REQUIREMENTS

• Proposals MUST be signed. Unsigned proposals will be rejected.

- Proposers may be required to give an oral presentation to the County to clarify or elaborate on the written proposal.
- No proposal will be accepted from nor any agreement awarded to any Proposer that is in arrears upon any debt or in default of any obligation owed to the County.
   Additionally, no agreement will be awarded to any Proposer that has failed to satisfactorily perform pursuant to any prior agreement with the County.

# GENERAL CONTRACT REQUIREMENTS

If the County selects a proposal and negotiations are successfully completed with the selected Proposer, a formal written contract, with specifications, will be entered into between the County and the successful Proposer. The proposal, or any part thereof, submitted by the successful Proposer may be attached to and become a part of the contract. After selection of the successful Proposer, a formal written contract will be prepared by the County of Westchester and will not be binding until signed by both parties and approved by the Westchester County Board of Acquisition & Contract and the Office of the Westchester County Attorney.

NO RIGHTS SHALL ACCRUE TO ANY PROPOSER BY THE FACT THAT A PROPOSAL HAS BEEN SELECTED BY THE COUNTY FOR SUBMISSION TO THE BOARD OF ACQUISITION

& CONTRACT FOR CONTRACT APPROVAL. SAID BOARD HAS THE RIGHT TO REJECT ANY RECOMMENDATION AND THE APPROVAL OF SAID BOARD IS NECESSARY BEFORE A VALID AND BINDING CONTRACT MAY BE EXECUTED BY THE COUNTY.

#### **Indemnification and insurance:**

If the Proposer is selected, the Proposer shall agree to the following:

• That except for the amount, if any, of damage contributed to, caused by or resulting from the negligence of the County, the Proposer shall indemnify and hold harmless the County, its officers, employees and agents from and against any and all liability, damages, claims, demands, costs, judgments, fees, attorneys' fees or loss arising directly or indirectly out of the acts or omissions hereunder by the Proposer or third parties under the direction or control of the Proposer; and

• To provide defense for and defend, at its sole expense, any and all claims, demands or causes of action directly or indirectly arising out of this Agreement and to bear all other costs and expenses related thereto.

If the Proposer is selected, the County of Westchester and the Proposer shall be named as insured on all policies obtained by the Proposer and Certificates of Insurance shall be furnished to the County of Westchester by the Proposer and an indemnity provision similar to that recited above will be included on all such insurance policies.

A currently dated Certificate of Insurance must be provided indicating the following coverage:

• General Comprehensive Liability of \$1,000,000.00 per occurrence for bodily injury; \$100,000.00 per occurrence for property damage •

Contractual Liability with same coverage

- Workers' Compensation for staff and enrollees
- Fidelity Bond of \$25,000.00 for each representative authorized to withdraw funds. This \$25,000.00 bond is required for any agency seeking an advance payment
- Automobile Insurance for owned, hired or non-owned autos: \$1,000,000.00/\$100,000.00
- Westchester County must be listed as an additional insured and certificate holder on all certificates of insurance.

All policies shall be obtained from companies licensed to conduct business in the State of New York. Companies providing insurance coverage shall be required to have nothing less than an "A" rating or better by the A.M. Best Company of Aldwich, New Jersey.

Insurance coverage in amount and form shall not be deemed acceptable until approved by The County of Westchester, Department of Risk Management. The Director of Risk Management may alter insurance requirements at his/her discretion.

#### **Confidentiality of Records:**

Each contracting agency must agree that all information, records, and data collected in connection with the contract shall be protected from unauthorized disclosures. In addition, the agency must agree to guard the confidentiality of recipient information. Access to recipient identifying information shall be limited by the agency to persons or agencies which require the information in order to perform their duties in accordance with the contract, including New York State, Westchester County, or the United States government. Any other party shall be granted access to confidential information only after complying

with the requirements of State and Federal laws and regulations pertaining to such access. The County shall have absolute authority to determine if and when any other party has properly obtained the right to have access to this confidential information. Nothing herein shall prohibit the disclosure of information in summary, statistical, or other form, which does not identify particular individuals.

Recognition/identification of the funding source:

In the recognition and/or advertisement of programs funded through this grant the following must be identified and to include the EEO statement as follows:

"This program is supported by The Westchester/Putnam Local Workforce Investment Board with Workforce Investment Act funds provided by the U.S. Department of Labor."

Further, all Proposers must disclose the name of any County employee who owns, directly or indirectly, an interest of ten percent or more in the firm or any of its subsidiaries or affiliates.

# **Compliance with laws:**

The preparation of proposals, selection of vendors and the award of a contract are subject to provisions of all Federal, State and County laws, rules and regulations.

#### **Non-collusion:**

The Proposer, by signing the proposal, does hereby warrant and represent that any ensuing agreement has not been solicited, secured or prepared directly or indirectly, in a manner contrary to the laws of the State of New York and the County of Westchester, and that said laws have not been violated and shall not be violated as they relate to the procurement or the performance of the agreement by any conduct, including the paying or the giving of any fee, commission, compensation, gift, gratuity or consideration of any kind, directly or indirectly, to any County employee, officer or official.

# **Termination of Agreement:**

The County may terminate an Agreement on thirty (30) days notice in writing when the County deems such termination to be in its best interest.

The County shall retain the right, upon the occurrence of any release by the Governor of a proposed budget of the State of New York and/or the adoption of the State budget or any amendments thereto, and after the County has a reasonable period of time to conduct an analysis of the impacts of such budget(s) on County finances, to terminate agreements or to renegotiate the amounts contained therein. If the County subsequently offers to pay a reduced amount to the contractors then the contractors shall have the right to terminate the agreements upon reasonable prior written notice.

# **Contents of proposal:**

The New York State Freedom of Information Law as set forth in Public Officers Law, Article 6, Sections 84-90, mandates public access to government records. However, proposals submitted in response to this RFQ may contain technical, financial background or other data, public disclosure of which could cause substantial injury to the Proposer's competitive position or constitute a trade secret. Proposers who have a good faith belief that information submitted in their proposals is protected from disclosure under the New York Freedom of Information Law shall:

a. insert the following notice in the front of its proposal:

The County assumes no liability for disclosure of information so identified, provided that the County has made a good faith legal determination that the information is not protected from disclosure under the applicable law or where disclosure is required to comply with an order or judgment of a court of competent jurisdiction.

The contents of the proposal, which is accepted by the County, except portions "Protected from Disclosure", may become part of any agreement resulting from this RFQ.

#### **Audit language:**

It is anticipated that the contract will include the following provisions:

The Provider agrees to submit to the County within one hundred twenty (120) days of the expiration each fiscal year which includes any part of the term of this Agreement, an audited financial statement and report of internal control, at Provider's sole cost and expense, for the preceding fiscal year prepared and signed by a Certified Public Accountant. The auditor shall comment that the funds provided by the County were spent in compliance with the Agreement and did not replace funds previously provided from another source nor contributed to any surplus. The financial statement shall include, but not be limited to, a summary of gross income and operating expenses attributable to the provision of services hereunder. Said summary shall be organized in conformance with the budget lines set forth in Schedule "B", if applicable. If the audited financial statement supplied by the Provider is not satisfactory in the reasonable opinion of the County Commissioner of Finance (or his designee), it shall be deemed a breach of contract by Provider and in addition to any other remedies that the County may have, the Provider s h a 11 not be eligible for any new contracts with the County for a period of up to five (5) years. The Provider shall establish and maintain separate accounting procedures for the funds provided hereunder which shall present an accurate record of the disbursement and use of the funds provided hereunder. Such accounting procedures shall conform to Generally Accepted Accounting Principles and Generally Accepted Auditing Standards. If Provider has a contract similar to this contract in all material respects in the year prior to the execution of this Agreement, Provider shall supply an audited financial statement and

report of internal control for the fiscal year which included the last year of such prior contract with the County within 120 days of the end of the fiscal year of Provider, unless agreed otherwise by the County Commissioner of Finance.

The LWIB shall withhold five percent (5%) of the amount of funds provided for each contract year until the County receives a satisfactory audited financial statement and report of internal control which is due to the County under the terms of this Agreement.

The LWIB shall have the right, at its option and at its sole cost and expense, to audit such books and records of the Provider as are reasonably pertinent to this Agreement to substantiate the basis for payment, regardless of whether the Provider has submitted its own audit hereunder. The County may withhold payment of funds hereunder for cause found in the course of an audit or because of failure of the Provider to cooperate with an audit. The County shall, in addition, have the right to audit such books and records subsequent to payment, if audit is commenced within one (1) year following termination of this Agreement, and to perform random audits during the term of this Agreement. In the event an audit received from the Provider or an audit done by the County reflects overpayment by the County or that monies were not fully expended or that monies were improperly expended, then the Provider shall reimburse to the County the cost of such audit (if the audit was done by the County or on the County's behalf) and the amount of such overpayment, underpayment or improper payment, within thirty (30) days of the notice from the County.

The Provider further agrees to permit designated employees or agents of the County reasonable on-site inspection of the work being performed by the Provider under this Agreement, its books, accounts, financial audits and records and agrees to keep records necessary to disclose fully the receipt and disposition of funds received under this Agreement. Unless the County shall, in writing, advise the Provider to the contrary, the Provider shall retain all financial records related to this Agreement for a period of six years after the expiration or termination of this Agreement.

In addition to any other remedies it may have, the County shall have the right to deduct from future contract payments, under any contracts the County may have with Provider, any funds the County may determine are owed to the County under this Agreement.

A proposal would not be considered complete if any of the application requirements or the budget limitation part is not met.

#### UNION CONSULTATION AND CONCURANCE

No program shall impair existing contracts for services, or existing collective bargaining agreements, unless the employer and the labor organizations concur in writing with respect to any elements of the proposed activities which affect such agreement, or either

such party fails to respond to written notification requesting its concurrence within 30 days of receipt thereof. If applicable, provide dates of negotiations which took place. The proposal shall not be funded until the problem is resolved. If the labor organizations comment on, object, or cite any problems related to the training design or choice of occupation, you must provide full details concerning the comments or objections and any negotiations which took place.

# **APPLICANT STATEMENTS**

The proposal must include statements of the following:
